SENIOR 700 TOURNAMENT RULES

1. Eligibility for this tournament is limited to bowlers who are current members of USBC, SD State USBC and a local South Dakota Bowling Association who have bowled at least one USBC Certified "700" 3-game series at some time during their bowling career. Participant must be at least 55 years of age at the time of participation.
2. This is a 6-line Singles Tournament bowled in two (2) **SCRATCH DIVISIONS - 199 and below average / 200 plus average.** Bowlers will be assigned up to 5 per pair of lanes, and bowl six (6) lines on two (2) lanes.
3. The entry fee is \$55.00 broken down as follows: Prize Fund - \$25.00, Lineage - \$19.00 and Expense - \$11.00. All prize money will be returned 100% in cash and awards in each division. An award will be presented to the champion in each division. In case of a tie for the championship of either division, co-champions will be declared and duplicate awards will be given.

Insufficient Funds Checks: Subject to \$30.00 charge and entry rejection.

4. **ENTERING AVERAGES:** Entrants in the SD STATE USBC SENIOR "700" TOURNAMENT must be members in good standing with the SD STATE USBC, a local South Dakota USBC association and USBC. The average to be used by the entrant must be their highest SD USBC certified league average, regardless of whether bowled as a regular or substitute, provided they have bowled 21 games or more. Averages will be accepted in the following order:
 - (A) Entrant must use their highest SD STATE USBC certified league average (single or composite), as of the end of the previous season. A minimum of 21 games is required.
 - (B) If "A" doesn't apply, an entrant shall use their highest SD STATE USBC certified average (single or composite) as of January 1, 2018. A minimum of 21 games is required.
 - (C) If neither "A" or "B" applies, use the highest current SD STATE USBC certified average (single or composite) as of the date of participation in the State Tournament. A minimum of 21 games is required.

(WRITTEN VERIFICATION OF AVERAGE MUST BE PROVIDED IF AVERAGE IS NOT AVAILABLE ON WWW.BOWL.COM, OR AT REQUEST OF THE TOURNAMENT MANAGER)

USBC Rule 319A 1-3-4 and 319C & E concerning submission of averages is in effect.
The 10 pin re-rate rule is not in effect.

5. All entries will be processed on a first-paid, first-served basis. Entries close with the last scheduled shift time of April 29, 2018. All entries must be submitted on an official entry blank, or a copy thereof, and must be accompanied by full entry fee prior to the start of the tournament. Telephone or e-mail reservations will be held for seven (7) days.
6. Any errors in scoring must be reported and corrected immediately. All scores as recorded on the scoring computer after the completion of each game will be declared final and official.
7. Any protest must be submitted in writing to the tournament manager within 72 hours of close of tournament. No unsigned protest will be considered.
8. **DRESS CODE: You must wear appropriate attire; no caps or shirts with offensive language / artwork will be allowed. Team Captains are responsible for ensuring team members adhere to dress code. Tournament Manager has final discretion as to appropriate attire.**
9. **CODE OF CONDUCT: Any obnoxious behavior and/or over consumption of alcohol that affects tournament play will NOT be tolerated. The result will be immediate disqualification and removal from the tournament.**
